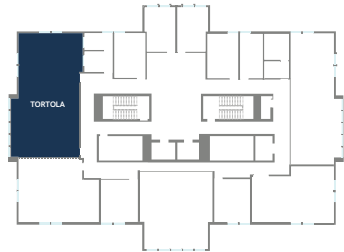

Accommodates 25-150 people, depending on room set-up

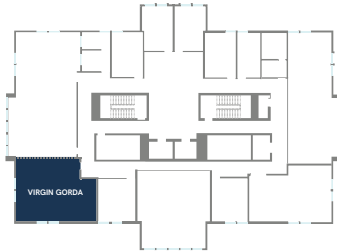
